2. Term of Consignment

The consignment term shall be ninety (90) days from the date of signing. At the conclusion of the initial term, both parties may mutually agree in writing to extend the Agreement.

3. Sales and Payment

The Bookshop shall retain forty percent (40%) of the retail price of each book sold as commission. The Author shall receive sixty percent (60%) of the retail price for each book sold. Payment for sold books will be issued within thirty (30) days following the end of the consignment term or upon earlier termination of this Agreement.

4. Pricing

The retail price shall be determined by the Author and agreed upon at the time of consignment. Any price adjustments must be approved in writing by both parties.

5. Inventory and Reporting

The Bookshop will make reasonable efforts to maintain accurate inventory and sales records. A summary of sales will be provided upon request at the conclusion of the consignment term.

6. Care and Responsibility

The Bookshop agrees to exercise reasonable care in handling and displaying consigned books. However, the Bookshop shall not be liable for loss or damage due to theft, fire, water damage, or other circumstances beyond its control.

7. Promotion and Display

The Bookshop will make reasonable efforts to promote and display the Author's books during events and regular operations. Specific placement or promotional prominence is not guaranteed.

8. Unsold Books

At the conclusion of the 90-day term (unless extended), the Author agrees to retrieve unsold books within thirty (30) days at their expense, or the books can be donated to the Bookshop, which will then use them in promotion or donate them elsewhere.

9. Termination

Either party may terminate this Agreement with ten (10) days' written notice. Upon termination, unsold books shall be returned to the Author at his/her/their expense, or they can be donated to the bookshop, which will then use them for promotion or donate them elsewhere.

10. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes all prior discussions. Any modifications must be made in writing and signed by both parties.
